
### 4th Policy Advisory Committee (PAC) Meeting of Bureau of Energy Efficiency

On 10th June, 2021 Bureau of Energy Efficiency, Ministry of Power, Govt. of India, had called the 4th



Policy Advisory Committee (PAC) meeting. The meeting was chaired by DG, Bureau of Energy Efficiency, and was attended by senior officials from Ministry of Power, Ministry of Petroleum & Natural Gas, Ministry of Coal, Ministry of Commerce & Industry, CII, ELCOMA, ISHRAE, TERI and IEEMA. IEEMA was represented by Mr. Anil Saboo, President, IEEMA; Mr. J Pande, Dy. Director General, IEEMA and Mr. Uttam Kumar, Sr. Executive Officer, IEEMA. The agenda for discussion was on Industrial Decarbonisation of Industry. President, IEEMA in his address mentioned that Decarbonisation is being achieved by increasing the share of low-carbon energy sources, particularly renewables, e-mobility and a corresponding reduction in the use of fossil fuels, to have joint R&D with European countries to facilitate knowledge sharing alongside technology transfer, and to cover all MSME under decarbonisation through policy interventions. In his remarks President-IEEMA stated that we firmly believe that the fight against climate change is fundamental for the future of all of us and that Indian industries must demonstrate the greatest possible commitment to limit the global warming by 2 degree.

On 11th June, 2021 President- IEEMA, Chairman and Vice Chairman of International Business division and other core committee members interacted with H.E. P. Kumaran, High Commissioner of India in Singapore and Mr. Jayaprahasam, First Secretary (Commerce), High Commission of India in Singapore over web conference.

President welcomed the High Commissioner and First

Secretary (Comm) and gave a brief snapshot about IEEMA and India-Singapore trade relations over past years.

High Commissioner shared opportunities of tie up with Singapore manufacturers in electronics as well as other key sectors like E-waste management etc. He also offered to support to connect with leading associations like SECA & SMF and Singapore Powergrid utility. Members also explored connecting with Universities working on R&D as well as having incubation centers for Start-ups for specific needs of Indian industry. It was felt that a paper on needs of Indian Industry in this space as well as on Technology transfers in electronics & other sectors need to be prepared by IEEMA in consultation with members to take forward the exploring opportunities with Singapore.

#### **Power Electronics Division Meeting**



On 11th June, 2021 meeting of Power Electronics division held through web. Major points discussed during the meetings were Product based segmentation of Power Electronics division, discussion on indigenization of high or critical power semiconductors and non- availability of credible testing facilities for power electronics & devices. 22 representatives attended the meeting.

#### Bureau of Energy Efficiency Stakeholders Consultation

On 11th June, 2021 Bureau of Energy Efficiency had called an all stakeholders' consultation meeting on 11th June, 2021 to seek comments on how the schemes of BEE can further be improvised to enhance the coverage and deployment of energy efficiency and conservation measures in the country. The meeting was chaired by DG, Bureau of Energy Efficiency and was attended by more than 400+ delegates from different sectors. IEEMA was represented by Mr. J Pande, Dy. Director General, IEEMA and senior members of Distribution Transformer and Rotating Machines Divisions. IEEMA requested BEE not to mandate Star rating to

Induction Motors, which are part of larger systems. Mr. Chanchal Jindal, Vice Chairman of IEEMA DT Division also mentioned that under Star & Labelling scheme of BEE, there should be provision for digital submission of all documents; approval time of certification may be reduced from 30 days to 2 to 3 days time and the requirement of type testing should not be applicable for all models as the requirement is already being considered under BIS certification and subsequently grouping guidelines may be formulated by BEE for meeting the type testing requirements.

#### Stakeholder's Consultation with NITI Aayog

On 11th June, 2021 Mr. Anil Saboo, President and Mr. Neeraj Nanda, Vice President, IEEMA, attended Stakeholder's Consultation on Capital Goods Industry. The consultation was chaired by Mr. Ishtiyaque Ahmed, Adviser, NITI Aayog, with an objective to understand the issues faced in enhancing competitiveness of capital goods industry and identifying actionable areas.

The Capital Goods Industry has a strategic importance on overall economic development by providing a strong foundational base to a large number of sectors. However, presently this Industry is witnessing various bottlenecks in becoming globally competitive.

IEEMA made a presentation in this Stakeholder's Consultation, highlighting various challenges faced by the electrical equipment industry, such as, Commodity Volatility, Lack of Demand and Liquidity, Export and Investment bottleneck, also making its recommendations in these regard.




