Sub: Change in base of Wholesale Price Index Number (WPI) to 2004-05 = 100

Economic Advisor, (MoCI) has informed by way of a press release dated 14th September 2010 (subsequently confirmed from their website www.eaindustry.nic.in) that the base of Wholesale Price Index Numbers (WPI) published by them has been revised from 1993-94 to 2004-05. Issuance of Index numbers as per new base has been started with effect from August 2010 (final indices published from June 2010).

IEEMA has been using WPI for 'Iron & Steel' (as per old base 1993-94=100) in PV circulars for products like Transformers, Switchgear, Instrument Transformers, Rotating Machines, Civil Works & Erection, Surge Arresters, Elevators/Escalators, Insulators, Battery Chargers and Bus Ducts. Further, we observe that WPI 'Iron & Steel' which was present in old base series no longer exists in the new base series.

We also observe that 'Iron & Steel' is a group level index consisting of various steel item indices at product level; now titled as 'Ferrous Metals' and consisting of more steel item indices including the ones already appearing in the previous 'Iron & Steel' group index.

After thoroughly studying and testing statistically the old 'Iron & Steel' indices and the new 'Ferrous Metals' indices for last five years, we were able to conclusively establish that the statistical equality in variation between these two above said indices is acceptable with high confidence.

We are therefore replacing the previous WPI of 'Iron & Steel' with the new WPI for 'Ferrous Metals' from June 2010 in the appropriate monthly IEEMA PV circulars.

IEEMA has been using WPIs for 'Fuel, Power Light & Lubricant' and 'Metal Products' in PV circulars including Surge Arrester and Elevators/Escalators. Similarly, WPIs for 'Cement', 'High Speed Diesel' and 'Structural Clay Products' are published in PV circular for Civil Works & Erection. WPI for 'Paints, Varnishes & Lacquers' is published in PV circular for Rotating Machines.

While on the subject we would also like to inform you that only the nomenclature of WPI for 'Fuel Power Light & Lubricant' has been changed as 'Fuel & Power'. However, all the individual items present under this remains unchanged. Similarly, nomenclature of WPI for 'Cement' too has been changed to 'Cement & Lime'.

Further, there is no change in WPIs for Metal Products', 'High Speed Diesel', 'Structural Clay Products' and 'Paints, Varnishes & Lacquers'.

We will henceforth be using the above WPIs of new base 2004-05=100 from June 2010 in the respective monthly PV circulars.

Please note that due to change in base, WPIs of old base published in our earlier PV circulars will not be comparable with the WPIs as per new base. We are therefore enclosing month wise final WPIs for 'Ferrous Metals', 'Fuel & Power', 'Cement & Lime', 'Metal Products', 'High Speed Diesel', 'Structural Clay Products' and 'Paints, Varnishes & Lacquers' as per new base 2004-05=100 from April 2005 to May 2010 as an Annexure- I

We request you to pick up and use the WPIs of appropriate month from annexure-I (in place of WPIs of old base already published in IEEMA PV circular) to arrive at price variation calculations.

We recommend using/applying the above guidelines ONLY for the pending contracts where WPIs for the month of June 2010 or further are involved in the said calculations.

You may be aware that IEEMA also publishes weighted indices for some products like Insulators, Battery Chargers and Bus Ducts. Weighted indices are calculated from a mix of 3-4 items with different costing pertaining to respective products.

We would like to inform you that here too the new weighted indices will be arrived at by appropriately factoring in the new WPI in place of old WPI at base level and these indices will be directly comparable with the indices published by us in the earlier respective monthly PV circulars.
