Venue shall be decided in consultation with Chair/Vice Chair.

Discussions / suggestions of improvement were discussed at large. It was decided to organise the next edition for more than one day as the last session was conducted in a hurry because of paucity of time.

Meeting with DDG Certification, Bureau of Indian Standards

On 5th August 2019, IEEMA delegation led by Mr. Alok Agrawal, Chairman Distribution Transformer Division, Mr. Ajay Sanghi, Vice Chairman, along with Distribution Transformer Division members met Mr. M.V.S.D Prasada Rao, DDG Certification and other Certification Heads to apprise them about the implementation issues w.r.t Steel and Steel Products Quality Control Order 2019. BIS Officials informed that the certificate of conformity under the Steel QCO 2019 is applicable on lot/batch of laminations, Cores delivered by lamination processor both under sale or job work, inter unit transfer of laminations/Cores. IEEMA highlighted the concerns of the industry that inspection of batch/lot will create delays/disruptions in supplies which in turn will levy penalties by Utilities/Discoms. DDG (Certification) advised IEEMA to represent Ministry of Steel for suitable extension in the implementation date. BIS also advised the delegation to submit different proposals for simplification of the BIS guidelines under scheme-V suggesting measures for simplification within a weeks time.

Power System Relays Sectional Committee Meeting, ETD-35

On 6th August 2019 Mr. Uttam Kumar, Sr. Executive Officer, IEEMA attended the 15th Meeting of Power System Relays Sectional Committee, ETD-35 at BIS, Manak Bhawan, New Delhi. The meeting was chaired by Mr. Rajil Shrivastava. Approx. 17 members participated in the discussion from 12 organisations. The important points which were discussed regarding organising meeting at least twice in a year, discussions on revising IS 3842-I and to prepare the draft on Application Guide for Electrical Relays for AC power system by end of the month. Chairman apprised members that comments received on draft standard of substation automation guidelines were similar in nature which had been already incorporated, however members may give their final comments, if any once the final draft is circulated. Chairman requested committee members to think upon challenges and issues associated with the grid integration of various renewable energy especially pertaining to solar energy and wind energy and study grid code practices followed by other countries. The next meeting was decided to be held in January 2020 at PowerGrid.

Mr. Jatia briefed Dr. Panda about the new initiative of the division on SME Clinique which will help the MSME members in availing consultancy services pertaining to Fund Raising, M&A, Bank Finance, Legal Matters, Estate Planning and Will, Wealth Management, Succession Planning and ERP Services. Metering India 2019





On 08th & 09th August 2019 IEEMA organized 8th edition of Metering India seminar at Hotel Le Meredien, New Delhi. The Seminar witnessed more than 550 participants from across all stakeholders of Metering ecosystem such as DISCOM officials, representatives from regulatory commissions, testing labs, system integrators, Meter Manufacturers and other components manufacturers. The Seminar was supported by Ministry of Power, Ministry of Electronics and Information Technology, Smart City Mission, Ministry of Housing and Urban Affairs and National Smart Grid Mission. There were total 5 technical session and 3 panel discussion exploring the technical aspects and policy perspective. The two days technical Seminar was followed by a technical tour to Smart Grid knowledge Centre, Manesar with support of NSGM & Power Grid where more than 60 delegates participated.
