Shri Misra briefed about the likely opportunities of Indian electrical industry to supply to the domestic and the world markets which were captured by the Chinese companies and also the likely impact to domestic electrical industry in getting essential raw material supplies from China, such as, the Meters manufacturing industry.

Shri R K Chugh, IEEMA President mentioned that for every manufacturing one of the major input is 'electricity'. There is a poor state of affairs in discoms, which are not financially vibrant and unable to make payments to their suppliers. Some measures were expected in the last Budget. IEEMA members also highlighted that some products under mandatory BIS certification, are sold without BIS licenses. Only state industry department can restrict the violation.
